Background

The Municipality of Swan Valley West seeks tenders from qualified individuals and companies for our gravel supply and crushing needs.

The Municipality uses crushed aggregate for our road and construction needs. Typically this includes ¾" aggregate but we do also use 1" material.

This tender is for both supply and crushing as well as combinations of both. It is our intention to issue more than one contract for supply and crushing so be able to better access available private resources.

Question must be submitted no later than 72 hours prior to the tender submission deadline.

Tender Opening and Award

All tenders received prior to the deadline will be opened at a public location. You may attend to observe the opening if you wish but attendance is not mandatory. Subsequent to the opening staff and council will review the tenders and will offer a contract to the selected bidder(s).

Terms and Conditions

The following terms and conditions apply to this tender:

1. Prior to contract issuance successful bidders must provide proof of WCB registration, insurance and all other required business documentation where applicable.
2. For Gravel supply the amount of material purchased is determined by the amount of material crushed at the location for current year payment. If we chose to purchase additional material that is not crushed, it will be part of a contract for future supply.
3. All crushed stockpiles must be measured by aerial drone to ensure the submitted crushing invoice matches the material on the ground. In cases where crushed material is being used directly during crushing the hauling invoices will be used to determine how much gravel was taken from the stock pile during crushing.
4. Crushed traffic gravel must contain 8-12% clay.
5. Swan Valley West will inspect gravel during crushing to ensure requirements are met.

Tender Information

Gravel Supply

Please provide a list of locations where you can supply gravel suitable for our needs. Additionally, please provide a map that indicates the approximate location of each of the resources you are bidding.

Indicate if the gravel is pit run or already crushed and indicate the price for each option. If you have a minimum purchase requirement include it in your bid.

If the gravel location is restricted to only allowing crushing by certain contractors indicate as such.

Gravel Crushing

Please provide a price for crushing gravel for municipal use. In this section, it is assumed that we have purchased the gravel from you or another vendor at the pit run price.

Your crushing services will not be considered for pits where you are not allowed to operate by the owner.

Indicate the minimum amount of material you are willing to crush in one location if mobilization costs are included in your per yard price. Or, indicate a separate mobilization cost for each move of your equipment.
